Comes now the State of Missouri by and through the undersigned Assistant Prosecuting Attorney on information and belief that there is probable cause to believe that the above-named defendant committed the following crime(s):

COUNT: 01 DOMESTIC ASSAULT - 2ND DEGREE - CLASS D FELONY

That Andrew M Hummel, in violation of Section 565.073, RSMo, committed the class D felony of domestic assault in the second degree, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about July 4, 2025, in the County of St. Louis, State of Missouri, the defendant knowingly caused physical injury to [REDACTED] by strangling, and [REDACTED] and defendant were family or household members in that she and the defendant were in a continuing relationship of a romantic or intimate nature.

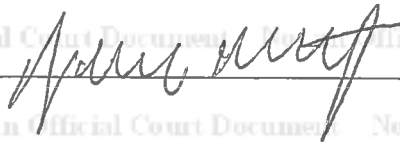
Count: 02 DOMESTIC ASSAULT - 3RD DEGREE - CLASS E FELONY

The facts supporting this belief are as follows: Officers responded to the Hilton hotel, located at 10330 Natural Bridge Road, in reference to a domestic disturbance. Officers were inform that there had been screaming and shouting coming from a room rented by Victim and Defendant. Officers made contact with Defendant in the room and observed one of his hands was cut and bleeding. Officers also observed blood on the bed in the room. Officers located Victim in the lobby female bathroom. Officers observed that Victim had a swollen lip. Victim stated that she and Defendant got into an argument and during it Defendant physically assaulted Victim. Victim stated that Defendant strangled her multiple times to the point that she could not breathe. Officers spoke with occupant of a room next to the one rented by Victim and Defendant, and she stated that she heard a female screaming and shouting "get off me" multiple times before and after reporting the noise to the front desk.

I believe that Defendant poses danger to a crime victim because during this incident Defendant struck and strangled Victim.
